A motion was made by Councilwoman Berry to appoint Kimberly Duffy as Borough Secretary, Francis Catania as Borough Solicitor, John McBlain as Zoning Solicitor, Giana Martin as Borough Treasurer, Anthony Tartaglia as Borough Manager, J.P. Kelly as Borough Engineer, Leitzell & Economidis as Borough Financial Agents, Commonwealth Code Enforcement as Code Enforcement Officer, Anthony Tartaglia as Building Inspector and Zoning Officer, Lou Pontarelli as Housing Inspector and Matt Fabrizio as Plumbing and Housing Inspector; seconded by Councilman Humphreys; and carried unanimously by a vote of 7-0.
