#### Police Report:

A motion was made by Councilwoman Papale to accept the Police Report as presented; seconded by Councilman Humphreys; and carried unanimously by a vote of 8-0.

### Fire Report:

A motion was made by Councilman Humphreys to accept the Fire Report as presented; seconded by Councilwoman Papale; and carried unanimously by a vote of 8-0.

# Treasurer's Report/Bill List:

### Manager's Report:

B&L Disposal presented information on the recycling issues, not only affecting the County but State and Country. The cost has gone from \$3/ton to \$65/ton and may go as high as \$100/ton by the end of 2018. This will affect future trash collection fees.

The Civil Service Commission was approved. Emil Pilacik was appointed as Chairman. Notice for Exam for a police officer test will be given on 10/18/18 at 9am as advertised.

The Planning Commission reported that a meeting took place on July 30, 2018 at 7pm.

A motion was made by Councilman Humphreys to appoint Ted Archer to the Planning Commission; seconded by Councilwoman Papale; and carried unanimously by a roll call vote of 8-0. (Resnick – yes, Rich- yes, Humphreys - yes, Martin – yes, Peterson – yes, Papale – yes, Campbell – yes, Berry – yes.)

The manager discussed looking into a Borough Administration Computer System.

A motion was made by Councilman Humphreys to accept the Manager's Report as presented; seconded by Councilwoman Peterson; and carried unanimously by a vote of 7-0.

# Engineer's Report:

J.P. Kelly presented the Engineer's report.

Mr. Kelly said that there was a meeting held to discuss the Borough Building renovations, and the contractor expects to have a subcontractor on site Saturday, August 25<sup>th</sup> to make trench repairs to the parking lot.

Mr. Kelly announced that the contractor had begun work on the CDBG project, and the work is currently 50% complete. The Contractor submitted an application for payment and the engineer is

recommending a release of \$124,786.90, which is 90% of the contractor's request. Mr. Kelly will forward the payment application to OHCD for payment.

A motion was made by Councilman Humphreys Council to authorize the engineer to reach out to OHCD to release the payment of \$124,786.90, as outlined by the engineer for the CDBG project; seconded by Councilwoman Papale; and carried unanimously by a vote of 8-0. (Resnick – yes, Rich – yes, Humphreys - yes, Martin – yes, Peterson – yes, Papale – yes, Campbell – yes, Berry – yes.)

## Solicitor's Report:

Frank Catania presented the Solicitor's report.

Mr. Catania announced that he would work with the Borough Manager as authorized to negotiate a contract renewal with Comcast.

Mr. Catania noted that they would need to discuss the engagement of the auditor to move forward with the 2<sup>nd</sup> phase of the audit for the delinquent sewer and trash.

A motion was made by Councilman Humphreys to accept the Solicitor's Report as presented; seconded by Councilwoman Papale; and carried unanimously by a vote of 8-0.
